Every student and faculty advisor participating in HMUN China must sign and return a legible copy of this form to HMUN China before registering at the conference. All names should be in English or pinyin and should exactly match the names inputted into their registration form. Students must also obtain a signature from a parent or legal guardian. All forms must be submitted as .jpg, .jpeg, or .pdf files. Incorrect submissions will not be processed. Students or faculty advisors without a completed release form on file by the deadline will not be permitted to register at the conference until the form is properly submitted, and until that time, will be unable to participate in any conference activities.
